Biographical or Historical Note

Archie Tippins Lyon (circa 1904-1957) was born in Roswell, Georgia. He was the son of Dr. Gustavus T. Lyon, a prominent local doctor, and Ada Paden Lyon.

Archie T. Lyon replaced his father, Dr. Gus Lyon, as druggist in the Lyon Drug Store on the corner of Main (Canton) Street and Elizabeth Way in Roswell.

Archie Lyon served in the United States Army from 1929 until 1930. Lyon re-enlisted in the Army and served again from 1942 to 1945.

Archie Lyon's first marriage to Bessie L. Lyon ended in 1947. Archie married Pearl "Butch" Lyon, his second wife, and their marriage lasted until his death in 1957. Pearl Lyon had two sons, Elmer and Noel Gilliam, from a previous marriage. Archie and Pearl Lyon purchased 612 Mimosa in the early 1950s.
